



## Preschool Tuition Guide 2020-2021 School Year

It is the mission of Living Stones Academy to make a Christ-centered education accessible to all families that desire it. To that end, families enrolling at Living Stones Academy have the option to pay full tuition or to request a sliding scale tuition arrangement based on household size and income guidelines.

Curriculum Fees	A non-refundable curriculum fee of \$100 is charged per preschool student. This is a one-time fee that does not count toward the first month's tuition payment.		
Income-Based Tuition Arrangements			

Living Stones Academy offers a sliding scale tuition rate to eligible families. Eligibility is determined by household size and the use of the Federal Income Guidelines (FIG). Families requesting a sliding scale tuition rate will be required to provide appropriate documentation. The monetary figures in the following chart represent annual household adjusted gross incomes (AGI) and corresponding minimum tuition requirements. Preschool rates listed are per *family*, not per child, with the exception of incomes over 200 percent of the FIG. Families that have two or more children in preschool will be expected to pay 1% higher on the tuition table than families with only one child in preschool.

For example, a family of 3 with a preschool student and household adjusted gross income (AGI) of \$22,000 as reported on 2019 Federal Tax Returns would fall between 100% and 140% of the FIG. Tuition required would be 7% of the household's AGI or \$1,540 for the year.

Payment Options	
Payment in Full	One-time payment via FACTS Tuition Management Company due August 1, 2020 (no fee from FACTS).
Monthly Payment	10 monthly payments via FACTS Tuition Management Company beginning in July 2020 (will also include a one-time fee from FACTS).
